This training involves specific techniques that are the exclusive property of FEI and that no other technicians have. FEI technicians are also the only technicians trained on disassembly and assembly operations on FEI products during microscope transfers. FEI is also the only company able to provide the spare parts, accessories and consumables of origin for FEI products. Also, no other company holds a license to perform software updates \(bug fixes\).
